

E-ticket prize drawing rules and regulations:

1. **Terms:** Prize eligibility commences with submission of a completed e-ticket at the door for admission to the 2013 Business Expo between the hours of 9:30 a.m. – 4 p.m. on May 1, 2013. Only one ticket per person will be allowed.
2. **Eligibility:** Entrants must be 18 years or older and submit a complete e-ticket for the 2013 Business Expo. Entrants may not be employees of the Greater Raleigh Chamber of Commerce, Diamonds Direct, or the NC State Fairgrounds.
3. **Entry:** Entry for the drawing requires the individual to submit a complete e-ticket and turn in for admission at the 2013 Business Expo. Entrant must meet all eligibility requirements.
4. **Prize:** The prize will be a \$500 gift certificate exclusively for the 2013 Business Expo to Diamonds Direct Crabtree. All taxes, duties, fees, and surcharges associated with the prize are the responsibility of the winner. Odds of winning will depend on the number of eligible entries received.
5. **Prize Drawing:** A random drawing will be conducted on Friday, May 3, following the 2013 Business Expo. The winner will be the e-ticket drawn out of all entrants that turn in their completed e-ticket for admission to the Business Expo and will be notified via email. If the selected winner does not respond to claim prize within 14 days, another entrant will be selected to take original winner's place.
6. **Redemption:** The Greater Raleigh Chamber of Commerce will mail the prize via UPS to the winner after the winner responds to original notification to claim the prize and verify mailing address to match that of original business listed on entry.
7. **Conditions:** In the event of a dispute, all entrants will be considered to be made by the authorized account holder of the email address provided on record at time of entry. The "authorized account holder" is deemed to be the natural person who is assigned to an email address by an internet service provider or other online organization that is responsible for assigning email addresses for the domain associated with the holder of the email address. Winner may be requested to provide the Greater Raleigh Chamber of Commerce with proof that they are the authorized account holder of the email address associated with the winning entry along with proof of personal identification.
8. **Other:** By entering in the contest drawing, the participant agrees that the Greater Raleigh Chamber of Commerce, its employees and representatives, will have no liability whatsoever for, and will be held harmless for any and all liability for any injury, loss or damages of any kind to persons and property, due in whole or in part, directly or indirectly, from the acceptance, possession, use, or misuse of the prize or participation in this contest or any prize related activity.
